No. 966 /R dtd.24.10.2013 X-3/2013

Pursuant to the resolution passed in the Full Court held on 01.10.2013 and 21.10.2013 Hon'ble the Chief Justice has been pleased to substitute the existing provisions contained in Rule-1, 3(1), 5, 6, 7 and 8 of Chapter-XV of the Orissa High Court Rules, Vol-I 1948 (4th Edition, 1983)

#### 1. Rule-I(a) and (b) Page- 31

Substitute the following for the existing provisions contained in Rule-1(a) and (b), Chapter-XV, page 31 of the Orissa High Court Rules, Vol-I, 1948 (4th Edition, 1983) as amended vide Correction Slip No.74.

- "1(a) An application for direction or writ of mandamus, prohibition, quo warranto, certiorari or any other direction or order under Article 226 of the Constitution or an application under Article 227 of the Constitution will be addressed to the Chief Justice and His Companion Justices of this Court and will be placed before such Division Bench or Single Judge as the Chief Justice may direct by a general or special order.
  - (b) Unless directed otherwise, the following categories of cases will be placed before a Division Bench:
    - (i) Writ Petitions relating to Public Interest Litigation.
    - Writ Petitions challenging the vires of any Act or any Statutory Order, Rule or Regulation.
    - (iii) Writ Petition against orders of SAT, CAT and relating to service of employees/officers of Judiciary.
    - (iv) Writ Petitions relating to admission into and recognition/affiliation of technical and professional educational courses.
    - (v) Writ Petitions in the nature of Habeas Corpus including all Writ Petitions pertaining to illegal detention.
    - (vi) Writ Petitions relating to Income Tax, Wealth Tax, Gift Tax, Central Excise, Customs Duty, Entry Tax, Value Added Tax, State Excise, Service Tax and Sales Tax.
    - (vii) Writ Petitions relating to Tenders,
    - (viii) Writ Petitions regarding D.R.T. and Bank Securitization, RDBI Act. OSFC and BIFR.
    - (ix) Writ Petitions under Orissa Estate Abolition Act, 1951.
    - (x) Writ Petitions relating to Lease and the Orissa Government Land Settlement Act, 1962.
    - (xi) Writ Petitions under the Special Courts Act.
    - (xii) Writ Petitions relating to immovable properties of Hindu Religious Endowments.
    - (xiii) Writ Petitions against the orders passed by the Orissa Electricity Regulatory Commission.
    - (xiv) Writ Petitions relating to Mines and Minerals.
    - (xv) Writ Petitions under the Land Acquisition Act.

Provided that when a Division Bench is not available and in all cases when a Single Judge functions as the Vacation Judge, a Single Judge may entertain an application under, Articles 226 or 227 of the Constitution and pass an interim order but no final order shall be passed by such Single Judge.

All other matters will be listed before a Single Judge".

#### 2.Rule-3(1), Page-32

Substitute the following for the existing Rule -3 (1) of Chapter-XV, Part-II at Page-32 of the Orissa High Court Rules, Vol-I, 1948 (4th Edition, 1983).

The applications shall be accompanied by a statement setting out the name and description of the applicant and of the party against whom relief is sought and the particulars of the proceeding/ proceedings which is/are sought to be challenged or quashed, and the grounds on which it is sought. The same shall also contain the provisions of law under which it is filed, the reliefs sought and the orders or actions impugned in the first few paragraphs. All such particulars as indicated in Appendix-I shall be duly and correctly furnished by the petitioner.

In the application, the petitioner, after supplying the aforesaid information, shall also incorporate in a separate paragraph whether alternate remedy, if any, available under any statute has been availed or not.

#### 3. Rule-5, Page-32

Substitute the following for the existing Rule -5 of Chapter-XV, Part-II at page-32 of the Orissa High Court Rules, Vol-I, 1948 (4th Edition, 1983).

"Every application shall be registered as Writ Petition (Civil) "W.P.(C)" except the application for Habeas Corpus registered as "WPCRL". Applications under Article 227 of the Constitution arising out of a Suit or a First Appeal shall be registered as Civil Miscellaneous Petition "C.M.P." and arising from any criminal proceeding shall be registered as Criminal Miscellaneous Petition "Crl.M.P".

#### 4.Rule-6, Page-32

Substitute the following for the existing Rule -6 of Chapter-XV, Part-II at page-32 of the Orissa High Court Rules, Vol-1, 1948 (4th Edition, 1983).

"The record of W.P.(C) or WPCRL and C.M.P. / Crl.M.P. except a case in which a memorandum has been filed for being listed on the day following the date of presentation shall be sent for stamp report on the day following the date of its registration. The Stamp Reporter shall return the record with his report on the next date of receipt thereof".

#### 5. Rule-7, Page-32

Substitute the following for the existing Rule -7 of Chapter-XV, Part-II at page-32 of the Orissa High Court Rules, Vol-I, 1948 (4th Edition, 1983).

"In W.P.(C) or WPCRL and C.M.P./ Crl.M.P., defects if any, pointed out by the Stamp Reporter shall be removed within five days from the date of publication of the defects in the Supplementary Cause List supplied to the High Court Bar Association, failing which the case shall be placed before the Deputy Registrar (Judicial) within three days thereafter for orders".

Provided that the Registrar may refer any matter to the Court for orders.

#### 6.Rule-8, Page-32

Substitute the following for the existing Rule -8 of Chapter-XV, Part-II at page-32 of the Orissa High Court Rules, Vol-I, 1948 (4th Edition, 1983).

"When the defects are not removed or when the orders of the Deputy Registrar are not complied with, in any case within the time allowed by him, the W.P.(C) or WPCRL and C.M.P. / Crl.M.P. shall be placed before the Bench within three days for dismissal."

N.B. The above amendments shall come into force w.e.f. 01.01.2014.

#### INSTRUCTIONS / GUIDELINES FOR FILLING UP THE CODING SHEETS

- The Coding Sheet procedure will be effective on and from the date of publication of notification in the Odisha Gazette, bringing an amendment to the Rules of High Court of Orissa, 1948. Till such notification in the Odisha Gazette, the practice which was hitherto prevailing will be followed.
- Object: Coding Sheet has been introduced with a view to enable the Registry to
  easily identify the cases as and when required and also for grouping similar cases for
  composite disposal. It will also enable the Registry, the learned counsels as well as the
  Court to ensure speedy disposal of cases if they are covered by earlier decisions.
- 3 The Coding Sheet in thick white paper is to be filed by the petitioner/appellant along with the filing papers after filling all the particulars in black ink leaving alone the portions to be filled by the Registry. The Coding Sheet shall be stitched with at the top of the Filing Papers.
- The Model Coding Sheets for Writ Jurisdiction, Review Petition, Caveat Petition, Civil
  Appellate Jurisdiction, Cross Objection, Original Jurisdiction, Criminal Jurisdiction and List
  of documents duly filled in are enclosed along with these Guidelines.
- 5. In the columns relating to the Petitioner/Appellant/Applicant or the Respondent or the name of the respective counsel, it is not necessary to fill the names of all the parties/counsel but only the names of the first petitioner and the first respondent and the name of the leading counsel alone.
- 5. The column 'connected/previous/covered cases if any' is meant for cases which are connected to the case being filed irrespective of the case types. For example, if a case is disposed of earlier on the same cause of action or on the case arising on the same provision though not relating to the same parties, it shall be mentioned in this column.
- 7 If the space provided for filling up the data e.g. 'connected/previous/covered cases if any' in the Coding Sheet is not sufficient, the particulars may be furnished below the respective boxes.
- Though almost all the Acts and possible subjects are covered in the existing list of nomenciature, there may be cases where the advocates while filling the Coding Sheet may find that the Act under which the impugned proceedings arise or the subject relating to the proceedings, does not find a place in the list. In such cases, they shall write the Act/Subject in the column 'Subject Matter/Act' without writing the Subject Category Code. They are requested to bring the same to the notice of the Deputy Registrar (Judicial). High Court of Orissa about the inclusion of the Act, which is missing in the list, who will take necessary steps to include the same in the list and update the same.

#### Instructions for filling up the Coding Sheets of Writ Jurisdiction:

The Act under which the impugned proceedings arise or the Act under challenge shall be mentioned in the space meant for 'Subject Malter/Act'. The corresponding code shall be mentioned in the space meant for Subject/Category Code. If the proceedings fall under any of the 'subject' specifically mentioned in the list, the same shall be mentioned followed by the corresponding Code.

#### Instructions for filling up the Coding Sheets of Original Jurisdiction:

The nature of the proceeding shall be mentioned in the space meant for 'Subject Matter/Act'. If the matter relates to release of arrear salary, the same shall be mentioned with Code No. as 311100- Arrear Salary.

#### 11. Instructions for the Coding Sheets of Criminal Jurisdiction:

The statute under which the major punishment is awarded shall be mentioned in the blank space provided for 'Subject Matter/Act'. If the case relates to any of the 'subject' specifically mentioned in the list, the same shall be mentioned followed by the corresponding Code.

For example, if the case relates to any of the provisions of the Code of Criminal Procedure, the same shall be mentioned followed by the Code Number 092100. However, if the proceedings relate to any of the specific subjects mentioned in the list under the Code of Criminal Procedure, e.g. Petition under Section 407 Cr. PC, the same shall be mentioned as 'Code of Criminal Procedure – Section 407'. The Subject Category Code shall, in this case, be 091200.

#### 12. Instructions for filling up the Coding Sheets of Civil Appellate Jurisdiction:

- (a) The nature of the suit before the Trial Court shall be mentioned in the space meant for Subject Matter/Act followed by the Subject Category Code.
- (b) Where the Appeal is against the order of the learned single Judge of the High Court, in the Coding Sheet in the column 'Court' in the Lower Court details, it shall be mentioned as 'Single Judge' and the District as 'Cuttack'.
- (c) In respect of Writ Appeals and all other appeals, the subject matter shall be the same as in the Writ Petitions and the original proceeding respectively.
- (d) In respect of Second Appeals, the details of the Trial Court as well as the Lower Appellate Court shall be mentioned.

#### 13. Instructions for filling up the List of documents under Appendix:XI:

List of documents annexed to every application, memorandum of appeal, counter affidavit etc. filed in the Court shall be submitted with necessary details with reference to the corresponding pages, in order to facilitate the preservation/return of the same as and when necessary by taking necessary endorsements in presence of the concerned officers of the Court.

14. Any application, memorandum of appeal, Cross Objection, Counter affidavit etc. filed in the Court without the duly filled up Coding Sheet / List of documents shall be considered as 'defect'.

#### NO. 967 /R Dated. 24.10.2013

In pursuance of the resolution passed in the meeting of the Full Court Dtd.21.10.2013 the High Court of Orissa do hereby modify the Standing Order No.1 of 2002 regarding nomenclature of cases as follows:-

"Resolved that registration of any petition arising out of a Suit or First Appeal under Article 227 of the Constitution be registered as "C.M.P." and any petition arising out of criminal proceeding be registered as "Crl.M.P." and not a Writ Petition (Civil) /WP(Crl.). The List of Nomenclature notified by the Court be amended to include "Petition arising out of a Suit or First Appeal under Article 227 of the Constitution" at Sl. No.(1)-A of (II) OTHER CIVIL PROCEEDINGS and petition arising out of criminal proceeding at Sl. No. (9)-A of (B) CRIMINAL PROCEEDINGS, indicating C.M.P. and Crl.M.P. respectively in the column "ABBREVIATION TO BE USED".

At Sl. No. (9) of (B) <u>CRIMINAL PROCEEDINGS</u>, the words "and other relief in relation to a criminal proceeding" be substituted by the words "and for challenging Preventive detention".

N.B. The above amendments shall come into force w.e.f 01.01.2014.
