**Sub: Skill Test and Computer Science Test (Practical) for the posts of Stenographer, Grade-III and Junior Typist in the Judgeship of Ganjam.**

Pursuant to the Advertisement No. 01/Rect./2022 dtd.23.07.2022, it is hereby informed that the **Skill Test** for the posts of **Stenographer, Grade-III and Junior Typist** of Ganjam Judgeship is scheduled to be held on **22.03.2023 (Wednesday)** from **10.30 A.M. onwards** in the **District Court Premises at Courtpeta, Berhampur, Ganjam- 760004.**

*The successful candidates for the posts of Stenographer, Grade-III and Junior Typist in the Written Examination held on 18.12.2022 are provisionally selected to appear in the aforementioned Skill Test.*

It is further informed that those candidates who will come out successful in the **Skill Test** on **22.03.2023** only will be allowed to appear in the **Computer Science Test (Practical)** scheduled to be held on **26.03.2023 (Sunday)** from **10.30 A.M. onwards** at **Parala Maharaja Engineering College, Sitalapalli, Berhampur, Ganjam- 761003.**

**Note :**

1. Admit Cards to the eligible candidates have already been despatched at their address mentioned in their envelope/ present address by Registered Post. Those eligible candidates who have not received the Admit Card by 20.03.2023 may collect duplicate Admit Card from the Office of the District Judge, Ganjam, Berhampur on 21.03.2023 during the office hours on production of a self attested photograph and proper identification.

*The selected candidates in the Skill Test are required to appear in the Computer Science Test (Practical) scheduled to be held on 26.03.2023 (Sunday) from 10.30 A.M. onwards at Parala Maharaja Engineering College, Sitalapalli, Berhampur, Ganjam, PIN- 761003. No separate Admit Card shall be provided to the eligible candidates to appear in the Computer Science Test (Practical) on the date fixed. So the candidates are advised to retain their Admit Card to appear in the Computer Science Test (Practical).*

2. The candidate shall report in the Examination Centre one hour prior to commencement of the examination.
3. Any sort of canvassing or attempt to influence the Officials related to the selection or recruitment process would result in immediate disqualification of the candidates.
4. In case of any dispute the decision of the Centre Superintendent will be final and binding on the candidates.
