Pursuant to the Advertisement under reference, it is hereby informed that the Skill Test / Computer Science Test (Practical) / Technical Knowledge in Survey & Settlement (Practical)/ Viva-voce Test for different base level Group-C posts in the Judgeship of Ganjam is scheduled to be held on **18.02.2024 (Sunday) from 09.00 A.M. onwards in the District Court Complex, Ganjam at Berhampur.**

The successful candidates of the Written Examination held on 10.12.2023 are provisionally selected to appear in the Skill Test/ Computer Science Test (Practical)/ Technical Knowledge in Survey & Settlement (Practical), as the case may be.

Admit Cards to the eligible candidates have already been despatched at their respective address mentioned in the envelope/Present address by Post. Those eligible candidates who have not received the Admit Card by 16.02.2024 may collect duplicate Admit Card from the Office of the undersigned on 17.02.2024 during office hours on production of a self attested photograph and proper identification.

The candidates are advised to report at the Examination Center one hour prior to the commencement of the Test (i.e. at 08.00 A.M.) along with the ORIGINAL TESTIMONIALS (CERTIFICATES), 3 (three) Nos. of passport size photographs similar to the photo submitted earlier with the Application Form and Admit Card.

- The eligible candidates for the posts of **Junior Clerk-cum-Copyist** shall appear in the Computer Science Test (Practical) and the successful candidates in the Computer Science Test (Practical) will be allowed provisionally to appear in the Viva-voce Test on the same day.
- The eligible candidates for the posts of **Stenographer, Grade-III** shall appear in the Skill Test (Stenography). The successful candidates in the Skill Test (Stenography) will be allowed to appear in the Computer Science Test (Practical) and the successful candidates in the Computer Science Test (Practical) will be allowed provisionally to appear in the Viva-voce Test on the same day.
- The eligible candidates for the posts of **Junior Typist** shall appear in the Skill Test (Type writing). The successful candidates in the Skill Test (Type-writing) will be allowed to appear in the Computer Science Test (Practical) and the successful candidates in the Computer Science Test (Practical) will be allowed provisionally to appear in the Viva-voce Test on the same day.
- The eligible candidates for the posts of **Salaried Amin** shall appear in the Practical Test on the Technical Knowledge in Survey & Settlement and the successful candidates in the said Practical Test will be allowed provisionally to appear in the Viva-voce Test on the same day.
