Sub: Skill Test/ Computer Science Test (Practical)/ Viva-Voce Test of different base level Group-C posts in the Judgeship of Ganjam.

Pursuant to the Advertisement under reference, it is hereby informed that the Skill Test / Computer Science Test (Practical) / Viva-voce Test for the posts of Junior Clerk-cum-Copyist and Stenographer Grade-III in the Judgeship of Ganjam is scheduled to be held on 09/03/2025 (Sunday) from 09.00 A.M. onwards in the District Court Complex, Ganjam at Berhampur.

The successful candidates of the Written Examination held on 15/12/2024 are provisionally selected to appear in the Skill Test/ Computer Science Test (Practical) as the case may be.

Admit Cards to the eligible candidates have already been dispatched at their respective address mentioned in the envelope/Present address by Post. Those eligible candidates who have not received the Admit Card by 06/03/2025, instructed to collect the duplicate admit card on 07/03/2025 from the office of Registrar, Civil Courts, Berhampur on production of original identity card and admit card of the last written examination held on 15/12/2024.

The candidates are advised to report at the Examination Center one hour prior to the commencement of the Test (i.e. at 08.00 A.M.) along with the ORIGINAL TESTIMONIALS (CERTIFICATES), 3 (three) Nos. of passport size photographs similar to the photo submitted earlier with the Application Form and Admit Card.

- The eligible candidates for the posts of Junior Clerk-cum-Copyist shall appear in the Computer Science Test (Practical) and the successful candidates in the Computer Science Test (Practical) will be allowed provisionally to appear in the Viva-voce Test on the same day.
- The eligible candidates for the posts of Stenographer, Grade-III shall appear in the Skill Test. The successful candidates in the Skill Test will be allowed to appear in the Computer Science Test (Practical) and the successful candidates in the Computer Science Test (Practical) will be allowed provisionally to appear in the Viva-Voce Test on the same day.
