- 1 Candidate without having proper original photo id proof shall not be allowed in the examination centre under any circumstances.
- 2 The Candidates should report at the examination centre at least 30 minutes before the reporting time mentioned on the examination notice.
- 3 The Candidate should bring their own **Short Hand notebook and pencil** to write his/her particulars, if any.
- 4 Candidate shall not be allowed to leave the examination hall after signature on the attendance sheet.
- 5 Candidate must follow the instructions strictly as mentioned in the notification available on website.

6 CANDIDATE MUST CARRY:

a. **ONE ORIGINAL PHOTO ID PROOF** (PAN CARD, AADHAR CARD, PASS PORT, DRIVING LICENCE, VOTER ID CARD) b. **Short Hand notebook and pencil**(GOOD QUALITY)

- 7 **LIST OF BARRED ITEMS WHICH ARE NOT ALLOWED IN THE EXAMINATION CENTRE IN ANY CIRCUMSTANCES :** METALLIC ITEMS ,BITS OF PAPERS, ELECTRONICS DEVICES , HANDBAG, MOBILE PHONES , EARPHONE, MICROPHONES , CAMERAS , HEADPHONES , PEN-DRIVES , BLUETOOTH DEVICE, CALCULATOR, FOOD and BEVERAGE (ALCOHOLIC OR NON-ALCOHOLIC) AND ANY OTHERS ITEMS WHICH COULD BE USED FOR UNFAIR MEANS .
- 8 If any candidate is in possession of any item(s) as mentioned above, his/her candidature for current examination will be cancelled and may also be debarred for future examination(s).

Candidates shall maintain proper silence at examination hall. Any conversation or gesticulation or disturbance in the Examination Room/Hall shall be deemed as misbehavior and treated under unfair means category. If a candidate is found using unfair means or impersonating, his/her candidature shall be cancelled and he/she will be liable to be debarred for taking examination either permanently or for a specified period according to the nature of offence.

Note: Examination date, Time and Venue shall not be changed under any circumstances nor any query or correspondence shall be entertained in this regard.
