**Note:**

- i) Only one candidate each from BC (A), SC category could qualify the test criteria for typing mistake out of two posts in each category. As per the conditions incorporated in advertisement/public notice, in case no candidate of reserve category (BC-A, BC-B, SC, ESM) is available then the seat of the same shall be filled from merit list of general category for Stenographers Grade-III (ad-hoc basis). As per the result criteria one post reserved for BC (A) category, one post reserved for SC category and one post reserved for ESM (General) category is left vacant and thus made available for appointment from the merit list of general category.
- ii) If any of the aforesaid candidates failed to accept the offer of appointment, then the candidate in order of merit list next in line will be considered for offer of appointment from the merit list of general category.
- iii) At the time of document verification, if any candidate's documents were found forged then his candidature for the aforesaid post shall stands cancelled.
