Candidates of reserved category of other State/U.T. will be considered as a candidate of general category. Reservation policy as enforced by Government of Haryana would be considered and applicable; provided that in case of non-availability of suitable candidate of reserved category for the Peon, the reserved posts shall be filled up from the suitable candidate(s) of general category.

Selection for the posts of Peons shall be made strictly in accordance with amended Rule 7 of Haryana Subordinate Courts Establishment (Recruitment & General Conditions of services) Rules, 1997.
