2. The Bidders should super scribe the words "OFFER FOR SALE OF DAMAGED ARTICLES AS SCRAP MATERIAL" on the sealed cover.
3. The sealed quotations should be submitted latest by 4.00PM of the dtd 09.10.2023 addressed to the undersigned.
4. The received quotations will be opened on dtd 10.10.2023 at 4.00 PM in presence of the available bidders or their authorized agent.
5. The offer price should be written clearly.
6. The highest bidders is to deposit the said/bid amount on the very date, opening of the bid, failing which his claim shall be forfeited and the next bidder will be entitled to take the same on payment basis.
7. The highest bidders is directed to take all such articles from the Court premises within 2 days of the bidding date falling which he has to deposit Rs.200/- per day as ground rent until clearance of the article.
8. The successful bidder shall take away the items on his own risk & cost and he shall be responsible for safe and appropriate disposal of the items. If any damage or otherwise is caused to the articles by any means during or after the stipulated period, no claim on this account will be entertained.
