- 3. The sealed quotations should be submitted latest by 4:00 PM of the dtd. 23.08.2024 addressed to the undersigned.
- 4. The received quotations will be opened on dtd 24.08.2024 at 10:30 AM in presence of the available bidders or their authorized agent.
- 5. The offer price should be written clearly, both in figures and words.
- 6. The highest offer above the upset price fixed shall be accepted and confirmed. The highest bidder is to deposit the said/bid amount on the very date, opening of the bid, failing which his claim shall be forfeited and the next bidder will be entitled to take the same on payment basis.
