- 3- The Authority has right to adjourn the sale to a specific date.
- 4- No public servant and no officers or other persons having any duty to perform in connection with the sale shall claim to acquire or attempt to acquire any interest in the property sold.
- 5- Sale will be confirmed in the name of highest bidders unless the Judge-In-Charge of the Store House thinks that the bid offered is grossly inadequate in which case property will be put to sale again.
- 6- The auction property shall be handed over to the buyer immediately after receiving of the auction money.
- 7- If the price is not paid immediately, the Authority reserves right to resale the property.
- 8- As the old Motor cycles, Luna and Scooter will be sold as per offset price fixed by M.V.I, Puri i.e Rs.58400/- for 32 Nos. of Motor cycle , Luna and Scooter.
- 9- The intending bidder have to filed a bank draft of Rs.1000/- in favour of Registrar Civil Courts, Puri to participate in the bidding process at the time of bidding.
