

In such a case, the Duty Magistrate concerned will intimate the next officer on duty, under intimation to the learned District &amp; Sessions Judge, Rohtak as well as the undersigned.</p> <p>Whenever, the Presiding Officer at Meham shall be on leave or training or station leave, the duty work of Meham shall be attended to by the Second Duty Magistrate at Meham and in his absence due to any of the reasons mentioned earlier by the Duty Magistrate at Rohtak</p>
3.	The Duty Hours shall start from 10:00 A.M. to 09:59 A.M. (on the next date) during holidays and otherwise, after Court hours till the Court hours of the next date.
