'OFFICE ORDER'

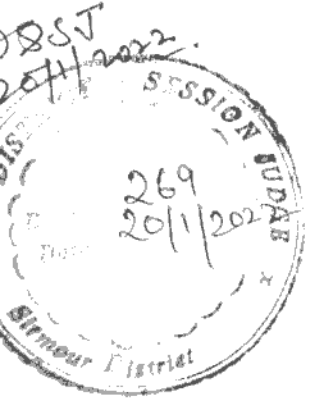
