OFFICE ORDER

In obeisance of orders passed by Hon'ble High Court of H.P., Shimla vide order No. HHC/RG/C-19/2020-31, dated 07.08.2020 and subsequent office order No.DSJ/EC/COVID-19/20 dated 10th August, 2020 issued by the Ld District and Sessions Judge, Sirmaur Distt. at Nahan, H.P. and also taking into consideration the fact that the physical distancing shall be required to be maintained with a view to check the community transmission of pandemic novel Corona Virus (COVID-19), the case files before this Court with effect from 18-01-2021 to 30-01-2021 other than D.V.Act cases, executions in Criminal cases U/s 25 Cr.P.C., Criminal cases for recording statement u/s 313 Cr.P.C., urgent matters as well as cases fixed for final arguments (Civil and Criminal) or final disposal or orders, and for evidence (02 Civil and 02 Criminal cases), and more than four years old cases shall be kept per instructions of Hon'ble High Court of H.P. this court to be made free from all such cases which are more than 4 years old before 31-03-2021 shall be taken up for the effective hearing in the following manner:-

The learned counsel for the parties who are interested in addressing the arguments through **V.C. or through WhatsApp video** shall address the arguments etc. accordingly. However, those learned counsel for the parties who are interested in filing written arguments may also file the same through e-mail or WhatsApp by **11:00 a.m.** on the date fixed for arguments. It would be the duty of the learned counsel for the parties to address the arguments in the Court by maintaining all norms of physical distancing. The parties through their Ld counsel are directed to proceed with their cases before the Court on the date fixed. This apart, the Courts shall also issue summons to the witnesses promptly well in advance, if any witness has not already been summoned. Only two Civil and two Criminal cases.

The Cases shall not be more than 4 years old, recovery of maintenance under section 125(3), or 128 of Cr.P.C, cases under protection of women from DV Act and cases under employees compensation and other industrial legislation and the criminal cases for which statements of the accused under Section 313 Cr.P.C. shall be treated as urgent cases and taken up before the court when the same are fixed on the date given in column no. 2. This Court shall also taken up those cases before this Court where consent is given by all the parties or their Id. Counsel.

The Court while the learned counsel for the parties are ready to appear, those cases shall also be taken up on the request of the parties hearing on the date fixed.

The urgent cases through e-mail can be done on e-mail id "esdca@si02@indiancourts.nic.in", before 4 P.M. which shall be checked by Sh. Sandeep Kumar, Naib Nazir, Sh. Rajendra Prasad and Sh. Sanjeev, Criminal Ahlmad and after properly scrutinizing and checking the same, they intimate to the Registrar who shall further intimate the undersigned. It is to be noted that hard copy shall not be entertained in the Court for any reason.
