**OFFICE ORDER**

In obeisance of orders passed by Hon'ble High Court of H.P., Shimla, vide order No. **HHC/RG/C-19/2020-31**, dated **07.08.2020** and subsequent office order No.**DSJ/EC/COVID-19/2020** dated **10<sup>th</sup> August, 2020** issued by the Ld District and Sessions Judge, Sirmaur Distt. at Nahan, H.P. and also taking into consideration the fact that the physical distancing shall be required to be maintained with a view to check the community transmission of pandemic novel Corona Virus (COVID-19), the cases fixed before this Court with effect from **01-02-2021 to 12-02-2021** other than D.V.Act cases, executions in Criminal cases U/S 125 Cr.P.C., Criminal cases for recording statement u/s 313 Cr.P.C., urgent matters as well as cases fixed for final arguments (Civil and Criminal) or final disposal of orders and for evidence (02 Civil and 02 Criminal cases), and more than four years old cases because as per instructions of Hon'ble High Court of H.P. this court is to be made free from all such cases which are more than 5 years old before 31-03-2021 shall be taken up for the effective hearing in the following manner:-



The learned counsel for the parties who are interested in addressing the arguments through **V.C. or through WhatsApp video call** can address the arguments etc. accordingly. However, those learned counsel for the parties who are interested in filing written arguments may also file the same through e-mail or **WhatsApp** before **11:00 a.m.** on the date fixed for arguments. It would be choice of the learned counsel for the parties to address the arguments in the Court by maintaining all norms of physical distancing. The parties through their Ld counsel are directed to produce the witnesses before the Court on the date fixed. This apart the Ahlmads shall also issue summons to the witnesses promptly well in advance, if any witness has not already been summoned only in two Civil and two Criminal cases.

The Cases which are more than 4 years old, recovery of maintenance under section 125(3), or 128 of Cr.P.C. cases under protection of women from DV Act and cases under employees compensation act and other industrial legislation and the criminal cases for recording statements of the accused under Section 313 Cr.P.C., shall be treated as urgent cases and taken up before the court when the same are fixed on the date given in column no. 2. This apart, the Court shall also taken up those cases before this Court, wherefore consent is given by all the parties or their Id. Counsel.

The cases, in which the learned counsel for the parties are ready to proceed further, those cases shall also be taken up on the request for effective hearing on the date fixed.

The filing of urgent cases through e-mail can be done on e-mail ID "[ecourts-hpsi02@indiancourts.nic.in](mailto:ecourts-hpsi02@indiancourts.nic.in)", before 4 P.M. which shall be checked by Smt. Shilpa, CCT, Sh. Sanjeev, Criminal Ahlmad and after properly scrutinizing and checking the same, they intimate to the Reader, who shall further intimate the undersigned. It is made clear that hard copy shall not be entertained in the Court on the same day.
