**'OFFICE ORDER'**

In exercise of the powers vested in me under Section 15 sub Section 2 of Code of Criminal Procedure and all other powers enabling me in this behalf, in suppression of all previous office orders on the subject, I, Partap Singh Thakur, Chief Judicial Magistrate, Sirmaur District at Nahan, H.P., for smooth distribution of business amongst Chief Judicial Magistrate, Addl. Chief Judicial Magistrate and Judicial Magistrates First Class of this Division for the purpose of remand, bail, other Misc. application and filing and disposal of main Criminal cases and proceedings do hereby order the following arrangement:-

**1. Courts Situated at Nahan.**

1. Remand, bail and other Criminal Misc. Applications except the applications for recording statements under section 164 of Cr. P. C. of female persons only pertaining to Police Stations, Sadar Nahan, (excluding P.P.s Katcha Tank and Gunnughat) Sangrah (EXcluding P.P. Nohradhar) and Vigilance, Nahan and Kala Amb shall be looked after and entertained by the undersigned.

2. Remand, bail and other Criminal Misc. Applications pertaining to Police Stations, Renukaji, Women P.S, Nahan, Police Posts, Gunnughat and Katcha Tank of P.S., Nahan shall be looked after and entertained by the Ld. Judicial Magistrate, Ist Class, Nahan, H.P.

3. All the Police Challans, Crl. Complaints and Criminal Proceedings except complaints under Section 138 of Negotiable Act and other Criminal Matters including summary cases of all types except the Misc. application referred here-in-above shall be presented in the court of respective court as per jurisdiction mentioned above.

4. All Criminal Complaints under Sections 138 of N.I. Act of the jurisdiction of all the aforesaid Police Stations shall be presented before the court of undersigned and thereafter distributed, in equal, proportion to this Court as well as the Court of Ld. Judicial Magistrate, Ist Class, Nahan, District Sirmaur, H.P.

5. All the applications under Sections 164 of Cr.P.C and under the POCOSO Act for recording statements of Female persons, in respect of all the aforesaid Police Stations shall be entertained by the Court of Ld. JIMC, Nahan and only in her absence by the undersigned.

## 2. Courts Situated at Paonta Sahib

1. Trial/Inquiries, filing of Police challans, Complaints of all type of Criminal cases, all others Criminal proceedings and remand, bail and other Misc. Applications pertaining to the jurisdiction of the Police Station, Paonta Sahib and Police Post Rajban of Police Station Puruwala shall be looked after and entertained by the Ld. Addl. Chief Judicial Magistrate, Court No. 1, Paonta Sahib.

2. All complaints under Section 138 of N.I. Act proceedings to the jurisdiction of Sub Division Paonta Sahib shall be presented before the court of Ld. Addl. Chief Judicial Magistrate, Paonta Sahib where from the same shall be distributed in equal proportion between the Courts of Ld. ACJM, Court No.I, Paonta Sahib and the Court of Ld. JMIC, Court No.II, Paonta Sahib .

3. Trial/Inquiries, filing of Challans, Complaints of all type of criminal cases, all other Criminal proceedings and remand, bail and other Misc. Applications ( except the Applications for recording statements under Section 164 Cr. P.C. only of Female persons ) pertaining to the Jurisdiction of the Police Station Majara, Police Stations Puruwala (except P.P. Rajban shall be looked after and entertained by the Ld. Judicial Magistrate Ist Class, Court No. II, Paonta Sahib.

4. All the Summary Cases shall be entertained and disposed of in the Court , as per the distribution of the Police Stations and Police Posts as mentioned above.

5. All the Criminal Misc. Applications u/s 164 of Cr.P.C. and POCSO Act for recording statements of Female persons in respect of Police Stations Paonta Sahib, Majra and Puruwala shall be entertained by the Ld. Addl. Chief Judicial Magistrate, Paonta Sahib. District Sirmaur, H.P., and in her absence by the Court of Ld. JMIC, Court No.II, Paonta Sahib.

3. **Court situated at Rajgarh**

1. Trial/Inquiries filing of Police Challans, Complaints of all type of Criminal Cases, other Criminal proceedings and remand, bail and other Criminal Misc. applications and Summary Cases of all types pertaining to the jurisdiction of the Police Stations, Rajgarh and Pachhad and Police Post Nohradhar of Police Station Sangrah shall be looked after and entertained by the Ld. Judicial Magistrate Ist Class, Rajgarh, District Sirmaur, H.P.

4. **Court situated at Shillai**

1. Trial/Inquiries, filings of Challans, Criminal Complaints of all types of Criminal Cases, other Criminal proceedings remand, bail and other Misc. applications and Summary Cases of all types pertaining to the jurisdiction of the Police Station Shillai shall be looked after and entertained by the Ld. Judicial Magistrate, Ist Class, Shillai, District Sirmaur, H.P.

5. **MISCELLANEOUS.**

Spot Trials of M.V Act challans shall be conducted by the Ld. Addl. CJM, Court No. I, Paonta Sahib and Ld. Judicial Magistrates First Class according to their jurisdictions as defined above. However, the undersigned can conduct spot trials of M.V. Challans within the jurisdiction of any Police Station in Sirmaur District and during such spot trials of the M.V. Challans, the S.H.O., concerned and the traffic Incharge of the area concerned shall be reporting and assisting the undersigned in conducting of Spot Trial in MV Act cases. However, the Incharge, Traffic Nahan along with his Traffic Police team shall report to the undersigned even when the undersigned shall be even on spot trials within the jurisdiction of other Police Stations.

The M.V. Challans which remain undisposed during the Spot trial by the Ld. Mobile Traffic Magistrate shall be filed before the Courts as per their defined jurisdiction as per this office order for disposal in accordance with Law.


6. ARRANGEMENTS DURING LEAVE OR ABSENCE




