

TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLE

1. The office of the District and Sessions Judge, Sirmaur District at Nahan, H.P. intends to dispose of condemned vehicle, on "**as is where is basis**".
2. Interested Parties may participate in Auction process on 22.12.2023 at 3.00 P.M at District Court Complex, Nahan, District Sirmaur, H.P., by depositing earnest money of Rs. 10,000/- in form of demand draft in favour of District and Sessions Judge, Sirmaur District at Nahan, H.P. .
3. The disposal of vehicle shall be strictly on "**AS IS WHERE IS BASIS**" and no guarantee or certificate of its worthiness or quality will be given by the Department. The condition of the vehicle can be inspected physically between 2.00 P.M to 4.00 P.M at District Court Complex, Nahan, District Sirmaur, H.P.
4. The 25 % of bid value shall immediately be required to be deposited by the successful bidder and remaining value shall required to be deposited with 03 days time positively, failing which his earnest money will be forfeited. In case the offer is withdrawn by any bidder, the earnest money deposited by him shall also be forfeited.
5. Earnest Money Deposit (EMD) of the successful bidder will be adjusted in 25% of Sale proceed amount. EMD of the bidder who fails to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD demand draft of unsuccessful bidder shall be returned within 7 days.
6. The delivery of the vehicle will be allowed only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card/Aadhar Card in case of individual and Registration Certificate in case of firms etc.)
7. The sold vehicle will be required to remove by the successful bidder(s) within 48 hours after depositing the entire consideration amount at their own expenses. No assistance / transportation will be provided by the office of the District and Sessions Judge, Sirmaur District at Nahan, H.P. Permission to take out disposed vehicle from the aforesaid premises will not be allowed on Govt. holiday and Sunday.
8. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
9. **The present registration number of the vehicles shall be retained by the District and Sessions Judge, Sirmaur District at Nahan, H.P. and will not be transferred to the bidder.** The highest bidder / the bidder who has been awarded the bid shall have to apply for new registration number for the vehicle as per the due procedure and process under the rules Motor Vehicles Act, 1988 at his cost only.
10. The Office of the District and Sessions Judge, Sirmaur District at Nahan, reserves the right to reject auction proceeding without assigning any reason thereof.

11. The bidders are required to reveal their full name / name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
12. Disputes, if any, shall be subject to jurisdiction in the Court of Nahan only.
