

ORDER:

The Recruitment Committee which was constituted for the selection of eligible candidates to fill up 11 posts of Process Servers and 32 posts of Peons and was later on requested to make selection of 02 more posts of Peons in the wake of creation of 02 more posts of Peons after publication of advertisement for recruitment, has submitted the final merit lists of selected candidates of each category for the aforesaid posts.

From the perusal of category wise merit lists of Process Servers, submitted by the Recruitment Committee, it reveals that the said Committee has made recommendation of selection of 05 candidates of General category, 02 candidates of Scheduled Caste category, 01 candidate of BC(A) category, 01 candidate of BC(B) category and 01 candidate of ESM(General) category. **The result of candidates under the Persons with Disabilities (Blindness and Low Vision) category has been withheld in view of recommendations of the Recruitment Committee, which has made request for seeking approval of interchange of vacancies of four categories of Persons with Disabilities.**

Similarly, from the perusal of category wise merit lists of Peons, submitted by the Recruitment Committee, it reveals that the said Committee has selected 16 candidates of General category, 05 candidates of Scheduled Caste category, 04 candidates of BC(A) category, 02 candidates of BC(B) category and 03 candidates of ESM of Different Categories (General, BC-A and BC-B) and 02 candidates under Outstanding Sports Persons (BC-A and SC). **The result of candidates under the Persons with Disabilities (A). Blindness and Low Vision, (B). Deaf and Hard of Hearing category has been withheld in view of recommendations of the Recruitment Committee, which has made request for seeking approval of interchange of vacancies of four categories of Persons with Disabilities.**

Appointment letters of 20 candidates selected as Peons, the posts of which were created in anticipation of joining of newly recruited Judicial Officers, who are expected to join in the month of February, 2024, would be issued on joining of the newly recruited Judicial Officers.

Appointment letters of Process Servers to first 05 candidates of General category, first 02 candidates of Scheduled Caste category, first 01 candidate of BC(A) category, first 01 candidate of BC(B) category and first 01 candidate of Ex-Servicemen (General) category from the aforesaid merit list of Process Servers shall be issued.
