3. In case, the Illaqa/Duty Magistrate happens to on leave or is unable to perform his duty due to medical or unforeseen emergency, his/her duty work shall be looked after by the next duty Magistrate of the same station.
4. In case, the Duty Magistrate relinquishes the charge, his duty work shall be looked after by the next Duty Magistrate, until the arrangements are made by learned District and Sessions Judge, Tarn Taran or Hon'ble High Court.
5. Ms. Gurpreet Kaur, SDJM, Khadoor Sahib is on medical leave w.e.f. 17.10.2023 to 08.11.2023 and the duty of said Court for the above said period of November, 2023 will be performed by the Duty Officer, Tarn Taran.


