- 2. The successful bidder/lessee will deposit 25 % of the lease money at the time of auction. The balance 75% of the lease amount shall be deposited within one month of the commencement of the lease period. In case of non-deposit of the lease money within the prescribed time, the deposit of 25% of the lease money shall be forfeited and the contract will be put to auction for the remaining period. The first lease shall be liable to pay the difference, if any between the lease money, if the subsequent lease is for the lesser amount.
- Contractors may operate Canteen/Parking/Shops during court working hours.
- 4. The participants will deposit refundable security amount of Rs. 10,000/- each which will be refunded to them after completion of auction proceedings and original receipts will be returned by them and their signatures will be obtained on presence sheet in token of return of security amount.
- 5. Contractor will be responsible for providing Canteen/Parking/Shops services from the date of contract i.e. 01.04.2024 to 31.03.2025. If he stops providing services midway, then his amount shall stand forfeited and will not be refunded in any eventuality.
- The Contractor shall bear all expenses and the Contractor shall be wholly and solely responsible for any dispute on account of noncompliance with rules/instructions.
- 7. The Contractor shall not make structural changes/modifications in Canteen/Parking and respective Shops.

- 8. The Contractor shall not employ any person below the age of 14 years.
- 9. The Contractor will enter into the agreement as per prescribed proforma.
- 10. The Contractor shall install an electric sub-meter in the Canteen/Shops at his own expenses and pay bill to the concerned electricity department.
- 11. No unapproved articles shall be kept in the Canteen/Shops for sale. The approved parking and articles rates shall be charged by the Contractor. He will also display approved rates of articles at prominent place in his respective Canteen/Parking/Shops.
- 12. The Contractor shall not sublet the Canteen/Parking/Shops to any other person.
- 13. The Contractor shall not sell the intoxicants/tobacco material in his Canteen/Shops..
- 14. The Contractor shall prepare and sell the fresh edible of good quality material in the Canteen.
- 15. The Contractor shall sole responsible for cleanness of the working area being used by them.
- 16. The Contract shall be liable to be canceled at any moment if the contractor is found doing illegal activities or providing services which are not in concurrence with the above mentioned terms and conditions and the deposited amount shall stand forfeited and will not be refunded in any eventuality.
- 17. The Ld. District & Sessions Judge reserves the right to reject the offer of any person without assigning any reason.
