Important Note:-

1. The Officer proceeding on leave or otherwise unable to perform duty work, shall make mutual adjustment with his/her colleague at the same station under intimation to this office. In case of leave of Judicial Magistrates at Patti the duty shall be performed by the Duty Officer at Tarn Taran with prior intimation and consent of the Duty Officer with specific intimation and consent of Ld. District and Sessions Judge, Tarn Taran and further intimation to this office.
2. In case, all the Judicial Magistrates at Patti happens to be on leave, the duty work shall be looked after by the Duty Magistrate at Tarn Taran.
3. In case, the Ilaqa/Duty Magistrate happens to on leave or is unable to perform his duty due to medical or unforeseen emergency, his/her duty work shall be looked after by the next duty Magistrate of the same station.
4. In case, the Duty Magistrate relinquishes the charge, his duty work shall be looked after by the next Duty Magistrate, until the arrangements are made by learned District and Sessions Judge, Tarn Taran or Hon'ble High Court.
5. The duty work of Sub-Division Khadur Sahib on holidays and on days when the SDJM, Khadur Sahib will be on leave, will be performed by Duty Magistrate, Tarn Taran.
