4. In case, the Ilaqa/Duty, Magistrate happens to on leave or is unable to perform his duty due to medical or unforeseen emergency, his/her duty work shall be looked after by the next duty Magistrate of the same Station.
5. All the remand work (from remand room) and urgent Criminal work will be done by the Duty Magistrate.
