6. The Contractor shall bear all expenses and the Contractor shall be wholly and solely responsible for any dispute on account of non-compliance with rules/instructions.

7. The Contractor shall not make structural changes/modifications in

Canteen and respective Shops.

The Contractor shall not employ any person below the age of 14 years.

- The Contractor shall install electric sub-meter in the shops at his own 10. expenses and pay bill to the concerned electricity department.
- No unapproved articles shall be kept in the said shops for sale. The approved article rates shall be charged by the Contractor. He will 11. also display approved rates of articles at prominent place in respective Canteen/Parking/Shops.
- The Contractor shall not sublet the shops to any other person. 12.
- The Contractor shall not sell the intoxicants/tobacco material in his 13.
- The Contractor shall prepare and sell the fresh edible material in the 14.
- The Contract shall be liable to be canceled at any moment if the contractor is found doing illegal activities or providing services which 15. concurrence with the above mentioned terms and conditions and the deposited amount shall stand forfeited and will not be refunded in any eventuality.
