

MINUTES OF MEETING DATED 25.01.2024 OF RECRUITMENT COMMITTEE

Today meeting of the Recruitment Committee has been convened to devise the criteria for making selection to the posts of Peon advertised vide Public Notice bearing endorsement No.282-87/E9 dated 04.01.2024. Total 1461 applications have been received till 20.01.2024 upto 5:00 P.M. i.e. the last date for submission of applications. The Committee consisting of Ms. Jasbir Kaur, learned Principal Judge, Family Court, Gurdaspur, Shri Rajesh Ahluwalia, learned Chief Judicial Magistrate, Gurdaspur and Ms. Ramneet Kaur, learned Additional Civil Judge (Senior Division), Gurdaspur is constituted for conducting interview of the candidates as per the schedule mentioned in the Advertisement. The said Committee shall interview the candidates and evaluate them on the following aspects:-


- I) **Appearance/ Confidence/ Personality;**
- II) **Etiquettes;**
- III) **Knowledge of work;**
- IV) **Special skill, if any; and**
- V) **General Awareness.**


The interview will be of 20 Marks. The qualifying marks for General Category Candidates would be 55% and for the Reserved Category Candidates would be 45%. The Committee shall assess the candidates as per the aforementioned criteria. After holding the interview, the Committee shall submit the report, recommending the names of the successful candidates.

However, as mentioned in the list **Annexure-A**, total 86 applications for the post of Peon have received after the stipulated period, therefore, these are stands rejected.
