

MINUTES OF MEETING DATED 09.02.2024 OF RECRUITMENT COMMITTEE

Today meeting of the Recruitment Committee has been convened to devise the criteria for making selection to the posts of Process Server advertised vide Public Notice bearing endorsement No.744-49/E9 dated 10.01.2024. Total 1658 applications have been received till 25.01.2024 upto 5:00 P.M. i.e. the last date for submission of applications. The Committee consisting of Ms. Jasbir Kaur, learned Principal Judge, Family Court, Gurdaspur, Shri Rajesh Ahluwalia, learned Chief Judicial Magistrate, Gurdaspur and Ms. Ramneet Kaur, learned Additional Civil Judge (Senior Division), Gurdaspur is constituted for conducting interview of the candidates as per the schedule mentioned in the Advertisement. The said Committee shall interview the candidates and evaluate them on the following aspects:-


- I) **Appearance/ Confidence/ Personality;**
- II) **Etiquettes;**
- III) **Knowledge of work;**
- IV) **Special skill, if any; and**
- V) **General Awareness.**


The members of the Committee can conduct the interview individually by constituting the different Benches and in case of necessity, they can avail the services of any other Judicial Officer posted at Headquarters, Gurdaspur after prior consultation with the undersigned.


The interview will be of 20 Marks. The qualifying marks for General Category Candidates would be 55% and for the Reserved Category Candidates would be 45%. The Committee shall assess the candidates as per the aforementioned criteria. After holding the interview, the Committee shall submit the report, recommending the names of the successful candidates.

However, as mentioned in the list **Annexure-A**, total 75 applications for the post of Process Server have received after the stipulated period, therefore, these are stands rejected.
