

PROCEEDINGS OF MEETING OF SELECTION COMMITTEE FOR COMPLETION OF PROCESS OF SELECTION OF COUNSELLORS (One CHILD COUNSELLOR & Two GENERAL COUNSELLORS)

Today, i.e., on 01.03.2024 a meeting of Selection Committee was held under the Chairmanship of District & Sessions Judge-cum-Chairman, District Legal Services Authority, Gurdaspur to draw the time limits for completion of process of selection of counsellors (One Child Counsellor & two General Counsellors). Secretary, District Legal Services Authority, Gurdaspur put up before the Committee letter No.559 dated 25.01.2024 of Punjab State Legal Services Authority, S.A.S. Nagar, whereby directions were issued to complete the entire process of recruitment by 20.03.2024. Secretary, District Legal Services Authority, Gurdaspur stated that total 06 applications have been received for the post of "Child Counsellor" and 11 applications received for the post of "General Counsellors", totalling 17 candidates to be interviewed by the Selection Committee. One application was received on 01.03.2024, i.e., after the last date for receipt of the applications which was fixed as 29.02.2024 through registered post, therefore, same is rejected by the Committee.

After due deliberations, the Committee has resolved that interview/interaction of the candidates shall be carried out in the post lunch session on 19.03.2024 in Conference Hall of District Court Complex, Gurdaspur.

The applications were scrutinized by the committee today and following discrepancies were found:
