

2. In case, Ld. Duty Magistrate relinquishes the charge, then the officer who is to perform the duty after the officer who has relinquished charge, will perform the duty till the next arrangement has been made by either Learned District & Sessions Judge, Gurdaspur or Hon'ble High Court.
3. In case, all Ld. Judicial Magistrates at Batala happen to be on leave/training, the duty work shall be looked after by Ld. Duty Magistrate at Gurdaspur. Learned Duty Magistrate is required to send the intimation regarding leave/Station Leave to the undersigned as well as to the Ld. Duty Magistrate at Gurdaspur.
