- e) there should not be any criminal proceeding pending against him/her.(an undertaking to be filed by candidate in this regard)
- f) Teachers (including retired teachers)
- g) Retired Govt. Servants and Senior Citizens
- h)M.S.W students and teachers
- i) Anganwadi worker/Doctors / Physicians
- j) Students & law students (till they enroll as lawyers)
- k) Members of non political, service oriented NGO and Clubs
- l) Members of Women Neighbour hood Groups, and other Self Help Groups including marginalized / vulnerable groups.
- m)Educated prisoners with good behaviour , serving long terms sentences in prisons:
- n)Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.

III. Fees for Examination:-

No examination fees is required to be paid by the candidates of any category.

- c) Two original Character Certificates issued by two different Gazetted Officers/ Medical Practitioner/Sarpanch etc. (Mentioning the name and designation of Officers);
- d) Two self-signed recent passport size photographs (One is to be affixed in the application form);

V. Procedure of Selection:-

PLVs shall be selected through personal interview by a Committee to be constituted by Chairman, DLSA, Bhadrak.

LAST DATE OF RECEIPT OF APPLICATIONS:-

The last date of receipt of application is fixed on 19.04.2024. Applications along with the required documents and self-attested copies of certificates shall be sent by the candidates by **REGISTERED POST/SPEED POST** so as to reach the Office of the Secretary, District Legal Services Authority, Bhadrak at District Court Complex, 3rd Floor, Po:Nalanga, Via:Barikpur bazar, Dist:Bhadrak, PIN:756112, on or before 5 p.m. on 19.04.2024.
