- (ii) Medical Fitness Certificate from the Medical Officer of a Government Hospital not below the rank of Asst. Surgeon.
- (iii) Two Conduct Certificates from two different Gazetted Officers.
- (iv) Caste certificate in original issued by the appropriate authority (for reserved categories).
- (v) Declaration of having not more than one spouse living, if married.
- (vi) An undertaking that he/she has not been dismissed from any Government service prior to joining in this department and no criminal case is pending or initiating against him/her.
