NOTICE

Applications are invited from the interested local residents to act as Para Legal Volunteer (PLV)/Nyaya Adhikar Mitra under District Legal Services Authority, Boudh. The term of Para Legal Volunteer/Nyaya Adhikar Mitra is for one year from date of joining. There is no provision of salary or remuneration or wages for the Para Legal Volunteer and only an honorarium may be paid as per guideline fixed by the appropriate authority and the amount shall be disbursed by the District Legal Services Authority.

Essential Field of Qualifications: The PLVs be selected from persons, who do not look up to the income they derive from their services as PLVs, but they should have a mind-set to assist the needy in the society coupled with the compassion, empathy and concern for the upliftment of marginalized and weaker sections of the society. They may be Teachers (including retired teachers), Retired Government servants and senior citizens, M.S.W students and teachers, Anganwadi Workers, Doctors/Physicians, Students & Law Students (till they enrol as lawyers), Members of non-political, service oriented NGOs and Clubs, Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/vulnerable groups, Educated prisoners with good behaviour, serving long term sentences in prisons or any other persons possessing **minimum qualification of matriculation or equivalent or above from any recognized institutions and having willingness to work as PLVs**. The PLVs shall be disqualified for selection if he/she fail to evince interest in the Scheme or has been accused of an offence, or has become physically or mentally incapable of acting as PLVs, or has so abused his/her position or misconduct in any manner as to render his/her continuance prejudicial to the public interest and if she/he is an active political enthusiast of a political party.

Age Limit: The applicant must have completed the age of 18 years by the last date of the application.

Last date: The application with required documents being completed in all respects in prescribed format given below with two colour passport size photographs addressed to the Secretary, District Legal Services Authority, Boudh, Dist- Boudh, Odisha- 762014 should reach the office of the District Legal Services Authority, Boudh by **18.02.2026** through post or by hand at the office on all working days.


