

The acceptance of quotation will be subject to the following conditions.

- 1. The District Judge, Thiruvananthapuram has the right of accepting or rejecting any or all the quotations without specifying any reason(s) thereof. The District Judge is under no obligation to accept the lowest quotation.
- 2. There is no obligation on the part of the District Judge,
 Thiruvananthapuram to inform the unsuccessful tenderer of the outcome of the
 tender process and reasons of rejection of the tender.
- 3. The quotations which do not quoted the rates of all the models for which the quotation is invited will be rejected.
- 3. The successful tenderer must execute the work immediately, up to a maximum down time of 24 hours, after acceptance of order.
- 4. The District Judge retains the authority to refill the toner cartridges and ink tanks/ replace the spares of the cartridges in the case of delay in the supply of the items within the period of 48 hours from intimation and recover the value of excess payment made for such purchase from the bill amount payable by the District Judge to the successful tenderer.
- A penalty of Rs.50/- (Rupees fifty only) per day will be deducted from the payment due if the issue has not been rectified within a downtime of 48 hours from the date of registration of complaint.
- 6. Withdrawal from the quotation after its acceptance or failure to execute the work within a specified time will entail cancellation of the order.
- 7. Representation for enhancement of rates, once accepted, will not be considered.

- 8. The rates quoted should be inclusive of all taxes, duties, cesses etc.
- 9. Payments will be made only after the repairs/refills and installation are actually verified and also on allotment of funds, after deducting the TDS applicable. The bills, in triplicate, shall be submitted in favour of the District Judge, Thiruvananthapuram.
- 10. Under no circumstances, shall the successful firm sublet the contract. If it is found that the contractor has violated the conditions, the contract will be terminated without any notice by the District Judge, Thiruvananthapuram.
- 11. The contract can be terminated by the District Judge, Thiruvananthapuram at any time without assigning any reason if the work of the contractor is found unsatisfactory. In this respect, the decision of the District Judge, Thiruvananthapuram, will be final and binding on the contractor.
- 12. Special conditions if any printed on the quotation sheets of the tenderer or attached with the tender will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.
