



OFFICE ORDER

In pursuance to the instructions contained in the Registry letter No.HHC/Admn.10(4)/98-XXVIII-12636, dated 4th May, 2024 and letter Endst.No.PER(AP)-C-B(2)-2/2015, dated 2nd December, 2023, Government of Himachal Pradesh, Department of Personnel (AP-III) and on the recommendations of the Screening Committee, the services of seven daily wage Peons of this Division listed below are hereby regularized after completion of 4 (four) years of continuous service (with a minimum of 240 days in a calendar year) as on 31-03-2024, in the Pay Matrix Level-1, plus other allowances as admissible from time to time with immediate effect against the post on which they are presently posted subject to furnishing medical fitness Certificate within a week. 
