"NOTICE INVITING TENDER"

Quotation for hiring consultant to prepare proposal(s) for diversion of forest land for non-forestry purpose i.e. construction of judicial buildings infrastructure at various places in Civil and Sessions Division, Mandi.

Sealed quotations are invited from reputed agencies/ firms for hiring a consultant to prepare FCA proposal(s) for obtaining forest clearances from the MoEF&CC or any other competent authorities, under FCA, 1980, for diversion of forest land for non-forestry purpose i.e. construction of judicial buildings infrastructure in following places of Civil and Sessions Division, Mandi, initially for a period of one year from the date of execution of agreement/ contract which term may be extended on yearly basis, subject to consent of both parties, the description of which is as under:-

Two separate sealed envelopes should be used for submitting **(i) Technical bid**, as per enclosed format **"Annexure-A"** consisting of all relevant details along with commercial terms and conditions; and Earnest Money Deposit **(ii) Financial bid**, as per enclosed format **"Annexure-B"** indicating the cost of services mentioned in the technical bid. Preference will be given to the firm or contractor having experience in the relevant field.

The bidders are required to submit the physical copy of the Technical bids and Financial bids along with the hard copy of the instrument submitted against earnest money in the sealed envelope by way of post or by hand to the District and Sessions Judge, Mandi, H.P. on or before **01.07.2024 up to 04:00 PM.**

The bidder shall have to furnish **earnest money deposit (EMD) i.e. 2% of the tendered amount** in the form of Demand Draft/ FDR duly pledged in the name of "the District and Sessions Judge, Mandi, Himachal Pradesh". However, exemption in depositing EMD is applicable for MSME registered firms. The earnest money of unsuccessful tenderer shall be returned within a reasonable time. No interest will be payable on the amount of the EMD. The EMD of successful tenderer shall be returned after furnishing of requisite Performance Security within stipulated period.

The Bid Security (EMD) may be forfeited:-

If a bidder withdraws his bid or increases his quoted prices during the period of Bid validity or its extended period, if any; or in the case of a Successful Bidder, if the Bidder fails to sign the Contract or to furnish Performance Security/Bank Guarantee within the specified duration. The Bidders are expected to examine all instructions, forms, terms and specifications in the Tender Document. Failure to furnish all the information required in the bidding Documents or submission of a Bid not substantially responsive to the bidding documents in every respect, shall be at the Bidder's risk and may result into rejection of the Bid. The Bid is liable to be rejected straightway without any intimation to the Bidder, if complete information as called for in the Tender Document is not given therein or if any particulars asked for in the Forms/ proforma in the Tender are not fully furnished.

The Bids shall contain no interlineations, erasures or overwriting except as

necessary to correct errors made by the Bidder, in which case, such corrections shall be initiated by the person or persons signing the Bid in original.

Consultancy services for FCA clearance shall include the following:-

B. **GENERAL TERMS AND CONDITIONS:-**

- 1) Bidders are requested to study the tender document and terms & conditions carefully. Submission of tender shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.
- 2) Firms intending to participate in the bid should first ensure that they fulfill all the eligibility criteria as prescribed under the terms and conditions, otherwise, the tenders will be summarily rejected.
- 3) The bid should be complete in all respect, with all documents duly signed by authorized person.
- 4) The bid document are not transferable.
- 5) The bid alongwith the EMD and other requisite supporting documents should be submitted in sealed envelopes only, addressed to "The District and Sessions Judge, Mandi, H.P.- 174001". The envelop should be duly superscripted "Quotation for hiring consultancy services for FCA clearance".
- 6) Open bids or unsigned bids shall be rejected straightway.
- 7) The bids should reach in this office within stipulated date and time, thereafter no tender/ bid/ quotation shall be entertained. The bid shall be opened on stipulated date and time.
- 8) The tender/ quotation submitted by post or courier shall be considered only if it is actually received before the specified date and time.
- 9) **FORMAT:-** The proposed rate should be quoted strictly on the proforma prescribed at Annexure-B.
- 10) The rates quoted in the bid should be inclusive of all taxes.
- 11) Proper name of the firm with business address, email ID and contact numbers

should be mentioned in the quotation alongwith supporting proof of Identity and address.

- 12) The firm should have a valid PAN number and copy of same should be enclosed with the bid/ quotation.
- 13) The firm should not be blacklisted/ terminated & debarred in the past. The firm is required to submit a declaration for the same with affidavit attested by notary.
- 14) **SELECTION CRITERIA:-** The L-I shall be determined based on the rates quoted by the bidder on Annexure-B, subject to fulfillment of other conditions.
- 15) **NON-CARTEL FORMATION:-** The bidder will not form a part of the cartel and put in supporting quotations for some other company. This will debar them from participating in other tenders floated or to be floated by this Civil and Sessions Division.
- 16) **NON-GRATIFICATION CLAUSE:-** The bidders will give an undertaking that they will not try to gratify any person or use any other unfair means involved in providing consultancy service for FCA clearance.
- 17) **NON-BLACKLISTED CERTIFICATE:-** The bidder will give an undertaking to the effect that they have not been blacklisted by any State/ Central Govt. Deptt./ other organization.
- 18) The District and Sessions Judge, Mandi or any other Competent Authorities reserve the right to accept or reject any tender whole or in part thereof, without assigning/specifying any reason thereof.
- 19) The District and Sessions Judge, Mandi or any other Competent Authorities reserve the right to modify any or all the conditions in the Tender document, prior to the date of submission of the Bid, by issuing an amendment in writing and such amendments will be binding on all the bidders.
- 20) **TERMINATION CLAUSE:-** The District and Sessions Judge, Mandi or any other Competent Authorities without prejudice to any other remedy for default/ breach of contract, may terminate the whole or part of the contract, by giving 7 days notice in writing:-
 - a. If the firm/contractor fails to provide the facilities mentioned above, within the stipulated period or
 - b. If the performance or service rendered by the firm/contractor is found to be unsatisfactory or
 - c. If the firm/contractor fails to perform any the obligation(s) under the contract.
- 21) Any dispute related to the tender process or execution of the contract thereafter shall be settled by the District and Sessions Judge, Mandi, whose decision shall be binding on all parties.

EARNEST MONEY AND PERFORMANCE SECURITY:-

1. **Earnest money:- 2% of the tendered amount (refundable)**
 - a) The quotation/ bid must be accompanied with earnest money i.e. **2% of the tendered amount** in the shape of Account Payee Demand Draft in favour of the District and Sessions Judge, Mandi – 175001.
 - b) Tender without earnest money or short or not in form prescribed above will be

rejected straightway.


- c) Earnest money shall be drawn in favour of the "District and Sessions Judge, Mandi", is to be deposited by way of Demand Draft.
- d) The earnest money of the unsuccessful bidder shall be released without interest after finalization of contract.
- e) The earnest money of the successful bidder shall be released without interest only after the bidder executes contract and submits Performance Security with the District and Sessions Judge, Mandi.

2. **Performance Security:- 5% of the tendered amount** (refundable)
 - a) Successful bidder shall have to furnish a performance Security i.e. **5% of the tendered amount** in the form of FDR or Bank Guarantee duly pledged/hypothetical in favour of the "District and Sessions Judge, Mandi" within 15 days after award of contract/agreement.
 - b) In the event of non-submission of the specified amount as performance Security, within the allotted time frame, the contract/work so awarded shall be liable to be cancelled without further notice.
 - c) The above FDR/Bank Guarantee should be valid for a period of sixty (60) days beyond the date of completion of contract.
 - d) In case of extension of the contract period beyond, the aforementioned Performance Security in the form of FDR/Bank Guarantee should have to be renewed and extended accordingly.
 - e) The Performance Security shall be refunded to the bidder only after successful completion of the contract period as well as completion of the task assigned to the successful tenderer.
 - f) Any lapse on part of the Contractor, non-abiding by the terms and conditions of this tender and subsequent contract or unsatisfactory services/performance, may result into the termination of the contract and lapse of the performance security.


