Sub:- Computer Section – eCourts Project – Hon'ble High Court of Andhra Pradesh – Supplied i3 Desktop Computer, for the use of District Judiciary in the Unit of West Godavari covered under eCourts Project - Instructions to place one monitor across the bench clerks/witness examination bench for a clear view of the depositions - Regarding.

It is brought to the attention from learned Bar Members that advocates and parties are facing difficulty while recording docket orders or evidence as they are unable to see the recording of evidence, consequently. Considering the request and the fact that the Hon'ble High Court recently supplied new computers, all the judicial officers in the District Unit West Godavari, are hereby instructed to place one monitor across the bench clerks/witness examination bench for a clear view of the depositions and court proceedings.

In this regard, the newly delivered all-in-one system can be used for the office work / chamber of the officer while leaving one monitor for the witnesses and advocates to go through while depositions are recorded.

The Data collected from your respective Courts is herewith annexured. The respective Court's presiding officers shall go through and see 3/2 monitors be present on the bench for the view of Presiding Officer and the witnesses/advocates.

All the judicial officers are hereby instructed to use "splitters" for using the monitors over the bench; if not available, it is permitted to purchase the same. Senior officers at the respective sub-units have to follow up and submit the report of compliance by September 30th, 2023.

This should be given priority.

Note: The new computers to be opened on the installation by authorized dealers.
