Respected Chief Justice,

As you are aware, 2nd October is observed as Swachh Bharat Diwas (SBD) to celebrate the Jan Andolan for Swachhata, as a tribute to Mahatma Gandhi on the day of his Jayanti. As a prelude to SBD-2023, the annual Swachhata Hi Sewa (SHS) fortnight is being jointly organized by Swachh Bharat Mission-Grameen and Urban (by the Departments of Drinking Water and Sanitation (DDWS) and Ministry of Housing and Urban Affairs (MoHUA)) w.e.f. 15th September to 2nd October, 2023. The theme of SHS-2023 is "Garbage Free India". The Swachhata Hi Sewa Campaign aims at adopting a whole of government approach to ensure visibly higher order of cleanliness through shramdaan (volunteerism) and jan-bhagidari (community participation). As a part of this exercise, a series of activities like cleanliness drives, repair of SBM assets-bins/public toilets, visit of students to waste processing plants, clearing of legacy dumpsites with community participation are envisaged.

2. As the various court complexes within the country are public premises, visited by thousands of citizens, I would be grateful if a similar exercise could be undertaken in these locations, as well, during this period so as to broaden and strengthen the government's endeavour, as indicated above.

3. I would, therefore, request your support and leadership in encouraging the active participation of your High Court and the District & Sub-ordinate courts within your jurisdiction to participate enthusiastically in this national campaign "Swachhata Hi Sewa-2023(SHS-2023)". I am also enclosing a brief on suggested focus activities alongwith this communication.

BACKGROUND AND SUGGESTED ACTIVITIES UNDER THE SHS CAMPAIGN-2023

Swachhata Hi Seva (SHS) campaign is being celebrated from 15th September to 2nd October this year under the joint aegis of Department of Drinking Water and Sanitation (DDWS) & Ministry of Housing and Urban Affairs (MoHUA) for undertaking **shramdaan** activities aiming to generate **jan andolan** through community participation; to provide impetus on implementation of SBM; to disseminate the importance of a **sampoorna swachh** village; to reinforce the concept of **Sanitation as everyone's business**; and as a prelude for the Swachh Bharat Diwas (2nd October) with nationwide participation.

Theme of SHS-2023 is '**Garbage Free India**' with focus on visual cleanliness and welfare of SafaiMitras. Like earlier years the spirit of cleanliness activities is **voluntarism/ shramdaan**.

Suggested Activities under the SHS Campaign are as under:

- Implement the "**Hara Geela Sookha Neela**" 2-Bin system for source segregation to promote effective recycling and waste management.
- Implement a "**Reduce, Reuse, Recycle**" program to minimize waste generation, encourage the reuse of materials, and promote recycling practices within the court premises.
- Promote the adoption of **eco-friendly alternatives to single-use plastics** to reduce plastic pollution and environmental impact.
- "**Zero Waste events**" may be organised within the court premises, where waste generation is minimized through careful planning and recycling, emphasizing sustainability and environmental responsibility.
- Ensure the provision of **clean and well-maintained public toilets** within the court complex to enhance the overall cleanliness and convenience for staff, litigants, and advocates.
- "**No Red Spots (Open spitting); Yellow Spots**" (open urination)
- Adopting Lifestyle for Environment (LiFE Actions)- To encourage individuals to adopt simple changes in their daily life that can contribute to climate change.
- Fortnight cleanliness plan with specific plan for 1st October- 2nd October, 2023.
- Cleanliness drive through field/ units during the fortnight with special focus on 1st October, 2023 in convergence with district administration and municipal authorities. Felicitation, prize giving on 2nd October, 2023.
- Large scale awareness drives to be conducted during the Pakhwada.
- All activities to be SUP free and zero waste events.
