Adverting to the subject and reference 2<sup>nd</sup> cited, I am to inform that the Hon'ble High Court of Andhra Pradesh directed all the Unit Heads to identify and refer at least 100 cases per day of different categories to the Chairpersons of PLAPUS (Permanent Lok Adalat for Public Utility Services) of the respective District for conducting Pre-Lok Adalat sittings to arrive for settlement/ compromise by the parties / Advocates through Mediation, Plea bargaining for placing them before the Lok Adalat and the progress shall be uploaded by the Chairpersons of PLAPUS to the Principal District Judge concerned and to the Member Secretary, APSLSA at the end of every day.

Hence, all the Judicial Officers in the District are hereby requested to identify and refer the fit cases on every day in different categories viz., all family matters like DOP, GWOP, FCOP, MC, DVC, 498-A of IPC (where trial is not commenced), Arbitration EPs (under Order-21 Rule-37 of C.P.C), MACT cases etc., (all pending cases except stay matters) shall be referred to the Chairperson, PLAPUS, Eluru for conducting Pre-Lok Adalat sittings so as to arrive at settlement / compromise by the parties/Advocates concerned and for placing them before the National Lok Adalat.

Judicial Officers other than Eluru are directed to send list of cases referred with case number, parties name, counsel names and their contact numbers to PLAPUS with a copy to DLSA. On considering the possibility of settlement, the file would be called for. Files need not be sent prior to this.

The Judicial Officers other than local courts in the district are informed to appraise the parties and learned Advocates that they can appear through Video Conference in their respective cases.

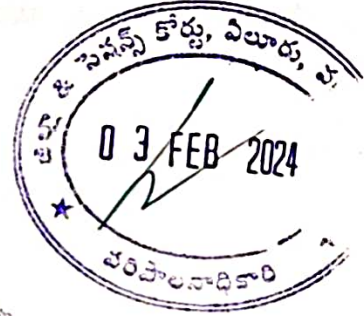
