Pursuant to the interview conducted for the post of Office Subordinate on outsourcing basis the following candidate is selected purely on temporary (outsourcing basis) to work at Legal Aid Defense Counsel System (LADCS), District Court Complex, West Godavari, Eluru as below subject to usual terms as per guidelines of NALSA Legal Aid Defense Counsel System Modified Scheme, 2022 and instructions of the Hon'ble A.P. State Legal Services Authority, Amaravathi issued from time to time.

Duties

- 1. Cleaning the office before the commencement of office hours.
- 2. Ensuring that all places in the office are kept clean.
- 3. Bringing and serving water, beverages to the visitors in the office.
- 4. Carrying dak etc.,
- 5. Any other work assigned by the District Legal Services Authority.

Conditions:

- 1. The LADCS scheme is introduced by the State or the staff for LADCS are not sanctioned by the State. The services of individual engaged for LADCS on outsourcing basis through APCOS such services do not come under the Rules of outsourcing staff of State.
- 2. The services of individual engaged under LADCS are purely temporary and the services may be terminated at any time without notice if the NALSA instructs to discontinue the scheme or discontinue the funding to run the scheme.
- 3. The individual is directed to enter into an agreement with the Secretary, District Legal Services Authority, West Godavari, Eluru from the date of his joining duty and re-enter the agreement after completion of every one year without fail.
- 4. These orders shall come into force with immediate effect.
- 5. The individual shall join duty **on or before 19.02.2024** and report before the Chairman-cum-Prl. District Judge, DLSA, W.G, Eluru, failing which his appointment shall stands cancelled.
- 6. The individual has to produce **Physical fitness certificate** issued by a competent Medical Officer not below the rank of Civil Assistant Surgeon at the time of his joining duty.
- 7. The above individual shall attend general duties as directed by the Chairman-cum-Prl. District Judge, District Legal Services Authority, West Godavari, Eluru as per the rules.
- 8. At the time of reporting duty, the individual shall furnish all relevant documents duly attested by the Gazetted Officer.
- 9. The individual is eligible for 15 days Casual Leave only for calendar year or proportionately to the actual outsourcing period / duty period. He is not entitled to any other leave.
- 10. The individual has to attend the duties promptly. If any deviation in attending the duties, the services of the individual will be terminated without any prior notice.
- 11. The individual shall not get any right for regularization of his post as it is under the scheme of LADCS.
