In order to accommodate the staff members, three optioned request places, where S.No.3 Smt. T. Lalitha Kumari, Typist, Principal Civil Judge's Court (Senior Division), Eluru has opted for Bhimadole, request of S.No.4 is considered.

S.No.7 - Smt. K. Rekha Ramani, Typist, IX Additional District Court, Kovvur working on deputation in IV Additional District Court, Tanuku, is promoted as Typist

from Process Server as per the proceedings Dt.29.04.2023, though not in general transfers list, her request is considered to accommodate S.No.17 - Sri G.V.V. Vara Prasad, Typist, II Additional Civil Judge's Court (Junior Division), Kovvur, who is under general transfers placing him in his three request places.

S.No.17 – Sri G.V.V. Vara Prasad, Typist, II Additional Civil Judge's Court (Junior Division), Kovvur, has opted three places. Among the opted places, to accommodate him though there is no Typist post in IV Additional District Court, Tanuku, posted him at Civil Judge's Court (Senior Division), Tanuku and further deputed to work in IV Additional District Court, Tanuku.

S.No.14 - Sri Md. Peer Basha, Typist, Additional Civil Judge's Court (Junior Division), Palakol, working on deputation in Principal Civil Judge's Court (Junior Division), Bhimavaram from 01.07.2022. Among three opted places, place of Bhimavaram is considered as the requests of the Staff Members in general transfers are mostly opting Tadepalligudem and Tanuku and to accommodate him at his opted place i.e., Bhimavaram is considered and posted at Principal Civil Judge's Court (Junior Division), Bhimavaram by cancelling his deputation.

S.No.16 – Smt. P.V.K. Rajya Lakshmi, Typist, I Additional Civil Judge's Court (Junior Division), Tadepalligudem, is not under general transfers list. Her request is there. In view of transfer of S.No.15, Sri S. Gopi, Typist, vacancy has arisen and among general transfers staff members, no specific member opted for Eluru, for administrative convenience the request of S.No.16 is considered.

The staff members are directed to get relieved and join in their new station / duty on or before **15.05.2024**.

- Note :-**
1. The Presiding Officer / Incharge Presiding Officer is hereby directed to relieve the staff member who is under transfer.
 2. The staff member who is under transfer shall hand over charge to the immediate senior member after completing all pending work, if any, and it should be duly attested by the Presiding Officer.
 3. The concerned Presiding Officers shall make the necessary in-charge arrangements for the place of the above individuals, and the individuals are directed to hand over the charge to the new assignee as per Principal District Court's Circular under the reference 4th cited and submit the charge list to the Principal District Court, Eluru.

In any case the concerned staff member could not handover the charge within time, they shall complete it within four weeks from the date of assuming charge at the new station and complete the pending charge, handover to the successor or to the member nominated by the concerned Presiding Officer.

Any deviation in the above without prior approval by the Principal District Court beyond four weeks, the concerned person who did not handover the charge shall be held liable in further irrespective of any other conditions. This condition is placed as this Office is receiving lot of representations for non-handing over of charges for years together which clearly leading to different departmental proceedings causing inconvenience to the staff members and to administration.

The concerned Presiding Officer shall take precautions passing appropriate office orders by placing in-charge while handing over the charge from the concerned staff members and see that no such stated circumstances of handing over charges would arise in future. Specific focus should be on appeal records, copy applications, issues, judgments, fair copies etc.

4. The order placed in the Principal District Court's website <http://districts.ecourts.gov.in/westgodavari> & the downloaded copy from the Website is valid for relieving and joining duty.
5. In any case, the staff member who is under transfer as per above proceedings is availing Leave / Casual Leave / Earned Leave / Special Casual Leave or any kind of leave shall proceed and join duty in the new station, immediately on completion of leave.
6. All the copies are communicated through e-mail followed by hard copy.
7. S.Nos.4, 7 and 16 are transferred at their requests, they are not entitled for joining time, T.A. & D.A.
8. For all convenience purpose, all the staff members who are under transfer shall be deemed to be working as on **30.04.2024**.
