Under the guidance of Hon'ble A.P. State Legal Services Authority, Amaravathi and as directed, this District Legal Services Authority has made attempts to identify a small Village/Villages as a Model Village.

A Model Village is, if it is “**Grievance Free Village**” or “**Litigation Free Village**”.

**Grievance Free Village** – is the village, where the grievances of different target groups in coordination with Departments of Revenue, Labour Welfare, Women Welfare and Tribal Welfare Department are addressed.

**Litigation Free Village** – is the village where legal assistance and advise is given in co-ordination with Police Departments to clear their legal cases.

With the above guidelines, this unit in co-ordination with Government Authorities Revenue and Police Departments, has made efforts by campaigning and could find the following villages as Litigation Free Villages in the District, West Godavari (Composite West Godavari).

#### **1. Gogunta village of Pedapadu Mandal**

Gogunta village is identified as work grievance and litigation free village. The village is located in 623 Hectares radius containing population of 800. The Major occupation of

villagers is on agriculture. Smt. Tummala Girija is the Sarpanch of Village. The village is having primary School, Road transport facility. This village has not seen any reported crime for the past 2 years (courtesy police dept.)

**2. Chilakalapudi Village of Tanuku Mandal**


From the Village Chilakalapudi, no Litigation is found from the village or against the villagers and is identified as a Litigation Free Village.

**3. Karagapadu Village of Gopalapuram Mandal**

Karagapadu Village has very minimal number of Criminal cases. The village is having population of 2,375 and it is found only 5 grievances. Efforts are under process, to provide legal assistance and other advices to make villages as Free from Litigation and grievances.

The efforts of the sarpanch of the Gogunta Village are appreciated of co-ordination and efforts to make the village litigation and grievance for the past 2 years.
