Sub: National Lok Adalat- DLSA, W.G., ELURU – Certain instructions to be followed by the Lok Adalat benches in the National Lok Adalat scheduled on 29.6.2024 - Reg.

2. General instructions issued by the Hon'ble Prl. District Judge, W.G., Eluru in Dis. No.965, Dated 25.6.2024.

In continuation of the General instructions under reference cited above all the Chairmen of MLSCs are hereby instructed to follow the check list so as to expedite the National Lok Adalats.

1. Wide publicity to be given. Secretary DLSA and all Chairmen of respective MLSC, have to make all possible attempts for wide publicity, print & electronic media. All the chairmen of MLSC's shall give wide publicity through media, personal interviews also.
2. Chairmen of MLSC's have to make attempts to identify more number of cases in their respective units.
3. Pre sitting Lok Adalats have to be conducted, post lunch.
4. All courts shall display in their notice boards and conspicuous places can be utilized as to pamphlet of NLA Scheduled on 29th June, 2024(5th Saturday).
5. PLVs, Panel Advocates or LADC services may be utilized. Verify Village Panchayats, Village Secretariats services, women police attached to Village Secretariats, can use their services in Matrimonial cases.
6. Focus be given on Execution Petitions, Arbitration Act cases.
7. MACT Cases, Insurance Companies to be called for through VC / Physical.
8. Compoundable Cases, NI Act Cases, to be verified for amicable settlement.
9. NBW's pending in each court (NI Act) to be identified, inform to the Counsels therein and see that, regular sitting would be held.
10. Meeting with Bar Associations, Public Prosecutors / DDO to be held and see that, at the last moment, there shall not be any setbacks. Alternate back up to be there.
11. Meeting with Bank Authority, Banks for PLCs.
12. Meeting with Police officials and Excise Officials.
13. Meeting with the Staff members be conducted and their opinion to be noted and see that, their views would be heard.
