Sub: D.L.S.A., W.G., Eluru - Organization of National Lok Adalat for settlement of all types of cases both pending and prelitigation on 14-9-2024 in all the places where the courts are situated in the District - Steps to be taken immediately for identifying the suitable cases - List of fit cases for settlement - Called for - Reg.

It is to inform that, as per the directions of the Hon'ble National Legal Services Authority and the Hon'ble A.P. State Legal Services Authority, Amaravathi, all the Legal Services Institutions have to conduct National Lok Adalat on 14-9-2024 (2nd Saturday) for settlement of all types of cases viz., Compoundable Criminal cases, NI Act. cases, Civil cases, Motor vehicle accident claims, Bank recovery suits, Matrimonial disputes, Land Acquisition cases, Electricity and Water bills etc., in all the places where the courts are situated.

In pursuance thereof, I request you to bestow your personal attention for the forthcoming National Lok Adalat and see that, good number of cases are disposed off. On perusal of the performance of the District and interaction with stakeholders, one of the key area, which is missing is identification of case well in advance. It appears most of the officers are identifying cases in the last few weeks of scheduled Lok Adalat.

Therefore, to avoid last minute rush, it is proposed to identify minimum 100 cases on your respective courts (subject to pendency).

Hence all the officers are hereby instructed to identify the fit cases for settlement for the forthcoming National Lok Adalat to identify 100 cases in the following categories;

	MVOP cases	up to Rs.5.00 Lakhs - Injuries with medical bills, Crime number and Police Station
2)	NI Act cases	Up to Rs.2.00 Lakhs with PS and address of the Accused
3)	compoundable IPC cases)	Pending within erstwhile West Godavari District
4)	Execution petitions	Arbitration matters - Arrest EPs
5)	Pronote	Along with Connected NI Act cases if any
6)	DVC, MC, 498-A	Sec. 498 – A requires 90 days period, however if the cases are identified along with connected cases, a possibility of amicable settlement in the compoundable cases would end 498 – A cases.
7)	DOP/HMOP	Where conflict can be resolved along with connecting cases.
	Refer for Mediation to PLAPUS	More number of MC, DVC, 498 A, NI Act, etc. to be referred. In case even if only one party appears, the matter may be referred to PLAPUS directing the appeared person to talk to PLAPUS and PLAPUS would contact opposite party. Appearance may be through VC from the respective MLSC.

Therefore, the Judicial Officers are instructed to send the list of 100 cases in the above categories to this Authority through e-mail (wgdlsa@yahoo.com) on or before 27.7.2024 in the following proforma to enable us to discuss with the concerned Department officials for amicable settlement and to proceed further.
