ORDER :: DATED : 18-07-2024

In reference to the aforementioned, for the (02 vacant positions as stated in the notification) of Senior Superintendent, six candidates are considered in a 1:3 ratio. The six candidates are

- 1.Sri M.Umamaheswara Rao, Superintendent, Additional Civil Judge's Court (Junior Division), Palakole.
- 2.Kum.T.Swaroopa Rani, Superintendent, Principal Civil Judge's Court (Junior Division), Narsapur, working on deputation in Judicial Magistrate of I Class Court, Jangareddigudem
- 3.Sri P.Raghu, Superintendent, Civil Judge's Court (Junior Division), Chintalapudi, working on deputation in Civil Judge's Court, Bhimadole.
- 4.Sri B.Srinivasa Rao, Superintendent, II Additional Civil Judge's Court (Junior Division), Kovvur.
- 5.Sri J.Venkata Rao, Superintendent, Principal Civil Judge's Court (Junior Division), Palakole, working on deputation in Civil Judge's Court (Senior Division), Bhimavaram.
- 6.Sri B.Thummanna, Superintendent, I Additional Civil Judge's Court (Junior Division), Tanuku working on deputation in IV Additional District Court, Tanuku

After reviewing their qualifications, performance, representations, and conducting hearings, taking into account seniority, Special Confidential Reports, and Service Registers, and finding no specific Disciplinary Actions initiated, the following candidates are provisionally selected and temporarily promoted as Senior Superintendents from the cadre of Superintendent.

1. **Sri P. Raghu**, Superintendent, Civil Judge's Court (Junior Division), Chintalapudi, working on deputation in Civil Judge's Court (Junior Division), Bhimadole, is temporarily promoted to the post of **Senior Superintendent** from the cadre of Superintendent and transferred and posted as Senior Superintendent in Special Court for Trial of cases under POCSO Act, 2012, Bhimavaram, in the existing vacancy and deputed to work in Civil Judge's Court (Junior Division), Bhimadole, until further orders.
2. **Sri J. Venkata Rao**, Superintendent, Principal Civil Judge's Court (Junior Division), Palakol, is temporarily promoted to the post of **Senior Superintendent** from the cadre of Superintendent and transferred and posted as Senior Superintendent in Special Court for Trail of Offences Against Women-cum-V Additional District Court, Eluru, in the existing vacancy and deputed to work at I Additional District Court, Eluru, until further orders.

- Note :-**
1. Kum. T. Swaroopa Rani has no qualification of bachelor degree as on the date of notification. Sri B. Tummanna reported he has no objection for selection of any of the candidates as he is junior.
 2. Sri J. Venkata Rao represented that he is having 40% of functional disability and he may be considered in differently abled persons quota.
 3. Sri M. Umamaheswara Rao, having qualification of Intermediate and obtained permission to pursue B.A., degree in open university, made a representation to consider his candidature as he is going to retire in 2026.

Sri P. Raghu and B. Srinivasa Rao objection for selection of Sri M. Umamaheswara Rao and gave representation that Sri M. Umamaheswara Rao did not possess the degree and the benefit of clause only to below the cadre of Junior Assistants. Whereas coming to Sri J. Venkata Rao, Sri B. Srinivasa Rao objection there is already a person in the same quota. There is no serious objection from Sri. P. Raghu to the representation of Sri. J. Venkata Rao. On considering the record, the record shows that no such person in differently able quota is working. Therefore, the quota under differently able persons is alive and un-filled. Hence, his candidature is considered.

4. With regard to Sri M. Umamaheswara Rao representation, while on consideration, he made a request through Principal District Court, to Hon'ble High Court to consider him by extending the clause which was given to below the cadre of Junior Assistants and extend the same to his cadre. Hence, his representation is forwarded to Hon'ble High Court and it is before Hon'ble High Court.
5. On the above representations, considering the qualifications considering the seniority, Sri P. Raghu found having required qualifications, is selected in open category and Sri J. Venkata Rao having required qualifications is selected in differently able persons quota.
6. In view of promotion of Smt. T. Ananda Lakshmi as CAO, one vacancy has arisen in the cadre of Senior Superintendents. Interviews are called for two posts only and two candidates are selected. The vacant post will be notified in due course.
7. Seniority of the candidates is as per the above seriatim.
8. The above individuals are hereby informed that their promotion to the post of Senior Superintendent (Cat.2), is made purely on temporarily basis and on emergency basis without any preferential claim and the same can be rescinded without any prior notice.
9. The above individuals are hereby directed to join in promotion post on or before 22-07-2024.
10. The above individuals shall deposit security for an amount of **Rs.50,000/-** in the shape of FDR duly pledging the same in favour of the Principal District Judge, West Godavari, Eluru, within 30 days from the date of their joining in the promotion post, as per Rule 22 of A.P.J.M.S. Rules, 2019.
11. If any of the above individuals are on Earned Leave / Medical Leave / C.L., shall join the new place immediately on completion of their respective leaves, without fail.
