Adverting to the subject and references cited above, I submit that the President/General Secretary of Bar Associations of Chintalapudi, and Bhimadole have submitted resolutions, under references 1st and 2nd cited, stating that the executive committees of their Bar Associations have unanimously resolved to abstain Court duties **on 01.07.2024** as a mark of protest in implementing "New Criminal Laws" in India.

I submit that the General Secretary of Bar Association of Palakol has submitted resolution, under references 3rd cited, stating that their Bar Associations has unanimously resolved to abstain from attending Court work **on 01.07.2024**, as a mark of protest in implementing "New Criminal Laws" in India. Again, submitted another resolution under reference 6th cited, stating that the members of their Bar Association unanimously resolved to abstain Court work from **03.07.2024 to 05.07.2024**.

I submit that the General Secretary of Bar Association of Narsapur has submitted resolution, under references 4th and 5th cited, stating that their Bar Associations has unanimously resolved to abstain from attending Court work **from 01.07.2024 to 05.07.2024** as a mark of protest in implementing "New Criminal Laws" in India.

I submit that the Civil Judges (Junior Division), Chintalapudi and Bhimadole submitted letters under references 7th and 8th cited, stating that the Advocates of respective Bar Associations have been attending to the Court proceedings from 02.07.2024 onwards, after one day of the abstention/boycott i.e., on 01.07.2024.
