For the cadre post of Stenographer Grade-I, for the existing vacancy of one post, the eligible candidates are called for personal appearance as per the seniority in Gradation List – 2023. Seven candidates are appeared.

J.Ramadevi, Stenographer Grade-II has qualification of B.Com. She has completed her probation and she is the senior most candidate. As per record, no departmental enquiries are pending. S.No.1 Smt. G.Phani Jyothi is the next candidate. However, she is the junior to S.No.1. Sl.No. 3 to 7 reported that their probation is yet to be declared.

In view of the above, the candidature of Smt. J.Ramadevi is considered and she is provisionally selected and temporarily promoted as Stenographer Grade-I from the cadre of Stenographer Grade-II.

 - 3. Smt. J.Ramadevi shall deposit security for an amount of **Rs.10,000/-** in the shape of FDR duly pledging the same in favour of the Principal District Judge, West Godavari, Eluru, within 30 days from the date of their joining in the promotion post, as per Rule 22 of A.P.J.M.S. Rules, 2019.
 - 4. Sri M.Biji Kuruvilla is directed to join duty in deputation Court on or before 05-08-2024.
 - If any of the above individuals are on Earned Leave / Medical Leave / C.L., shall join the new place immediately on completion of their respective leaves, without fail.
