- (iii) Claim petitioner can make modifications/ repairs alterations/ improvements to the properties as far as to suit his conditions of living if it is a constructed house or otherwise with prior permission from the competent authority. The competent Authority shall accord permission as early as possible upon satisfaction.

The relief of raise the attachment over the schedule properties of above claim petitioners is hereby dismissed.

The interim attachment orders of State of AP holds valid and its orders merge with the orders of State of Karnataka as far as the GO Ms No.21 properties relevant to the properties of State of Karnataka are concerned. The orders of attachment to the properties other than at the state of Karanataka under the GO Ms No. 21 interim order of attachment continues with a liberty to the competent authority for the State of Andhra Pradesh to take steps as per provisions of A. P. Depositors Act to make absolute.

Accordingly, all the petitions are disposed off.
