 - 4) The Jail Visiting Lawyers shall visit the Prison Legal Aid Clinic in most disciplined manner and shall follow the NALSA's SOP of Prison Legal Aid Clinic, 2022.
 - 5) The NALSA's SOP on "Access to Legal Aid Services to Prisoners and Functioning of the Prison Legal Aid Clinics, 2022" is herewith enclosed.
 - 6) The Jail Visiting Lawyers, Community PLVs and Convict PLVs shall assist the Secretary, DLSA, West Godavari, Eluru during the visit of PLAC, to ensure better performance and to achieve the object of the NALSA's SOP of Prison Legal Aid Clinics, 2022.
