The Principal Civil Judge (Senior Division), Eluru is hereby instructed to specifically monitor the progress in the institution, disposals and cross check the property orders if any passed or any other reasoned orders that the officers have passed.

The Principal Civil Judge (Senior Division), Eluru is further instructed to regularly cross check the property left unattended after seizure or otherwise and give appropriate instructions.

The Principal Civil Judge (Senior Division), Eluru is also instructed to get data with regard to record rooms and their pendency. The Principal Civil Judge (Senior Division), Eluru instructed to submit report on the following week of review work.

The proceedings will come into force from 24.08.2024.
