In references to the cited above, the Principal District and Sessions Judge, West Godavari, Eluru, passed the following Order :-

On considering the Seniority, Special Confidential Reports and Service Registers, having found no specific Disciplinary Actions are pending, the following individual is temporarily promoted from the cadre of Process Servers to the cadre of **Field Assistant** in the existing vacancy.

S.No.	Name & Designation of the Employee	Place of Working	Temporarily promoted and posted as
1.	Sri B. Somulu, Process Server.	Civil Judge's Court (Junior Division), Chintalapudi.	Temporarily promoted as Field Assistant and posted in XI Additional District Court, Tadepalligudem, in the existing vacancy. Further deputed to work in II Additional Civil Judge's Court (Junior Division), Tadepalligudem, until further orders.

Note 1 :-

- I. The vacant posts in the category of Field Assistant – District Unit, West Godavari, in the promotion quota is – 07 (seven in number). This Office has called for the required qualified persons from the cadre of Process Servers for the vacant posts. In the cadre of Process Servers, **34 candidates** were called for interviews. In the cadre of Process Server, all the candidates have attended the interview.

The requisite qualification for the post of Field Assistant is, Bachelors Degree.

In the cadre of Process Servers 30 numbers of persons have not secured eligibility of Bachelor Degree to get promotion and some of them have reported that they have not interested and they have not applied for higher post.

S.No.27 – Sri Shaik Kamal, Process Server, has got permission to pursue higher study from the Hon'ble High Court and with the permission, he completed first year B.A., and he did not complete the Bachelor Degree.

S.No.25 – Sri Bhukya Somulu, Process Server, is the senior most persons followed by **S.No.27** – Sri Shaik Kamal, who applied for permission for pursuing Bachelor Degree followed by **S.No.32** – Smt. K. Parvathi, Process Server, and **S.No.34** - Sri P.D.N.S. Prasad, Process Server who completed Bachelor Degree, but they are not in the cadre of seniority.

Previously, **S.No.25** – Sri Bhukya Somulu, Process Server called for promotion to the post of Field Assistant from the feeder category of Process Server. He is having required qualifications. However, he was given punishment under Departmental Enquiry in D.E.No.2/2019, with holding two increments with cumulative effect Dt.15.10.2020. As per G.O.Ms.No.968, General Administration (Services-C) Department, Dt.26.10.1995, two increments with cumulative means for four years not eligible for promotion. Four years is nearly completed. The Departmental Appeal is preferred by the individual and it is pending.

Considering the individual twice is not considered for promotion and four years is almost completed, qualification that the individual has

considered for promotion and he is temporarily promoted as Field Assistant subject to outcome of departmental appeal and quash proceedings before the Hon'ble High Court.

- II. The above individual is hereby informed that his promotion to the post of Filed Assistant (Cat.10), is made purely on temporarily basis and on emergency basis without any preferential claim and the same can be rescinded without any prior notice.
- III. The above individual is hereby directed to relieve from the Civil Judge's Court (Junior Division), Chintalapudi on the AN of 09-09-2024.
- IV. The above individual shall deposit security for an amount of **Rs.10,000/-** in the shape of FDR duly pledging the same in favour of the District Judge, West Godavari, Eluru, within 30 days from the date of their joining in the promotion post, as per Rule 22 of A.P.J.M.S. Rules, 2019.
- V. It is hereby informed to the individual that his seniority in the promotion post will be fixed as per the above seriatim.
- VI. If the above person is on Earned Leave / Medical Leave / C.L., shall join the new place immediately on completion of his respective leaves, without fail.
- VII. The order placed in the District Court's website <http://districts.ecourts.gov.in/westgodavari> and downloaded copy from the website is valid for relieving and joining duty.

Note 2 :- The promotion is subject to outcome of administrative appeal and quash proceedings before the Hon'ble High Court.
