Pursuant to the directions of the Hon'ble Executive Chairman, A.P. State Legal Services Authority, Amaravathi, the next National Lok Adalat scheduled is to be organized on 14-12-2024 (2nd Saturday) as scheduled by NALSA for settlement of all types of cases viz., Compoundable Criminal cases, NI Act. cases, Civil cases, Motor vehicle accident claims, Bank recovery suits, Matrimonial disputes, Land Acquisition cases, Electricity and Water bills etc., in all the places where the courts are situated.

In this regard the Chairpersons of Mandal Legal Services Committees are instructed to take all necessary steps including the following:

- Cause identification of 100 cases under different categories.
- Special focus be given for settlement of long pending cases.
- Arrange meetings with the stakeholder Departments viz., Insurance Companies, Bank, Excise officials, Municipal Authorities, Police, Advocates.

- Cause wide publicity about the National Lok Adalat by way of News items, Radio and TV message, whatsapp message and through Panchayat Office.
- Make use of the Services of PLVs and Panchayat Raj Office.
- Issue proceedings of Benches to conduct Pre Lok Adalat sittings on daily
- Refer the cases to the Chairperson, PLAPUS for conducting Pre Lok Adalat sittings on daily basis.
- Conduct periodical meetings in physical or virtual mode with the Judicial Officers and other stakeholders to ensure participation of the party advocate in the Pre Lok Adalat sittings so as to arrive settlement in the matter.
- Call for the list of Compoundable Criminal cases from Police Department (Station wise).

I therefore, request you to send the identified case information and weekly statement (category wise) in the enclosed proforma to this Authority on or before 15-10-2024 and on every Thursday by 2.00 pm for onward submission to the Hon'ble A.P.State Legal Services Authority.
