

In case the officers mentioned in column no.3 are either on leave or for any other reason are absent from duty, the respective Principal District Judges shall make alternative incharge arrangements in respect of the officers mentioned in column no.2 and intimate the same to the High Court.

On return from the training, the officers mentioned in column no.2 shall rejoin duty in their respective post and also take charge the posts which they are holding full additional charge.
