It is proposed to fill up **Twelve (12) posts** of Junior Assistants (**Category-08**) by way of selection of eligible candidates from the feeder categories i.e., Examiner/Copyist, Record Assistant, Senior Driver/Driver and Process Server at the ratio of **8:4:1:3**.

As per amended A.P.J.M.S.S. Rules 2019, the cycle has been given for promotion of Junior Assistants by Direct Recruitment and by Promotion from the combined seniority of Examiners (Cat.11)/ Copyists (Cat.12) and appointment by transfer from the post of Record Assistants, Drivers and Process Servers by fixing the ratio of 8:4:1:3 in a cycle of 16 vacancies as prescribed hereunder:

If there is no qualified and suitable member in above 16 points Cycle at any level, the turn lapse and the said vacancies shall be filled by next turn in the order of rotation. No account shall be taken of any such lapsed turns in filling future vacancies.

As per G.O.Ms.No.76, Law (L, LA & J-Home-Courts.A) Department, Dt.15.05.2019, the method of appointment for the category of **Junior Assistant** shall be as follows:

- 1. 50% by Direct recruitment;
- 50% by promotion of Examiners (Cat.11) / Copyists (Cat.12) from the combined seniority and promotion of Record Assistant /Roneo Operator / Lift Operator (Cat.15 (a)(b)(c), Senior Driver / Driver (Cat.13 & 14) and Process Server (Cat.16) by fixing ratio of 8:4:1:3 in a cycle of 16 vacancies as prescribed in Note.2.

As per amended A.P.J.M.S. Rules 2019 in Rule-8, the minimum qualification prescribed to hold the post of Junior Assistant is <u>Must be a Graduate from any recognized University and also having knowledge or qualification in computer operation</u>. The following individuals in the common gradation of Examiners (Cat.11)/ Copyists (Cat.12) and appointment by transfer from the post of Record Assistants, Drivers and Process Servers are the persons for promotion as Junior Assistants subject to considering their seniority, since the posts of Junior Assistants (Cat.8) are non-selection posts.

As per G.O.Ms.No.4, Department for Women, Children, Differently Abled and Senior Citizens, Dt.09.02.2019, providing 4% reservation for each category in Promotion to the disabled employees.

As per the Government Orders in vogue, in promotions there should be adequate representation from the candidates belong to SCs (15% out of total strength), STs (6% out of total strength) and Differently Abled (4% out of total strength).

As submitted above, 12 posts of Junior Assistants are to be filled up by promotion from the feeder categories i.e., combined seniority of Examiners (Cat.11) and Copyists (Cat.12) and appointment by transfer from the post of Record Assistants, Drivers and Process Servers by fixing the ratio of 8:4:1:3 in a cycle of 16 vacancies.

As per Gradation List 2023, on the strength of seniority, the following members are hereby listed for the promotion, subject to meeting the conditions. vacancy position is twelve (12), the number of candidates to be empanelled from feeder category i.e. Examiner/Copyist/Record Assistant/Process Server in the ratio of 8:4:1:3 in a cycle of 16 vacancies to the post of Junior Assistant. On

considering the above conditions, the following employees are identified and called for interview in cadre of **Process Servers**.
